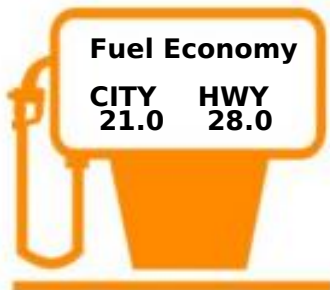

- Cracked or damaged case which is visible
